

Running Mate Terms of Use

These terms of use are entered into by and between you and Running Mate Corp. (“**Company**,” “**we**,” or “**us**”). The following terms and conditions, together with any documents they expressly incorporate by reference (collectively, “**Terms of Use**”), govern your access to and use of <https://getrunningmate.com/>, the Running Mate mobile application, and any content, functionality, and services available therein (collectively, the “**Website**”), whether as a guest or a registered user.
